TRANSPORT FOR THE EAST MIDLANDS RESPONDS TO MIDLANDS RAIL HUB **ANNOUNCEMENT**

Plans for the Midlands Rail Hub have received a boost after Ministers released an initial £123m funding injection to increase services between Birmingham and Cardiff, Bristol, Cheltenham, and Worcester.

A spokesperson for Transport for the East Midlands, said: "Whilst we welcome this funding, there must also be investment to improve rail services between the West Midlands and Derby, Leicester, and Nottingham."

"Existing services from the East Midlands to Birmingham are slow and infrequent and there are no direct trains to Coventry at all."

"The East Midlands continues to receive the lowest level of transport funding per head of any UK region or nation and has the highest level of car dependency in the country."

LOCAL TRANSPORT FUND ALLOCATIONS RELEASED

This week, the Department for Transport announced the new £4.7 billion Local Transport Fund (LTF), proposed to improve transport connectivity in the North and the Midlands.

Announced as part of the DfT's Network North, the Midlands is set to see £2.2 billion of the total £4.7 billion fund over seven years from April 2025 until March 2032.

The East Midlands will receive just over £1.02 billion in additional LTF funding over that time:, broken down as follows:

Leicester £159,559,000

Leicestershire £238,154,000

Lincolnshire £262,339,000

North Northamptonshire: £149,208,000

Rutland: £49,341,000

West Northamptonshire: £162,831,000

The East Midlands Combined County Authority, which includes Derby, Derbyshire, Nottingham and Nottinghamshire, will receive a City Region Sustainable Transport Settlement, allocations for which have not yet been confirmed by DfT.

EAST MIDLANDS COMBINED AUTHORITY GIVEN FINAL GO AHEAD

This week, the last legal step to establish the East Midlands Combined County Authority (EMCCA) has been signed and made into law.

Jacob Young MP, Levelling Up Minister, has signed the regulations that allow for EMCCA to be created. The authority will now be able to begin hiring and making administrative decisions in preparation for the East Midlands Mayoral election on Thursday 2 May 2024.

Once the mayor is elected, the authority will be able to start making decisions across its range of new powers currently held by Westminster, including public transport and housing.



LGIU REPORT WARNS COUNCILS AT RISK OF BANKRUPTCY

According to a new report from the Local Government Information Unit, more than half of the country's senior council figures have warned that their council is likely to go bankrupt within the next parliament unless funding changes.

Chief Executive of the LGIU, Jonathan Carr-West, who last month presented at the East Midlands Councils General meeting, said: "With over half of councils warning us they are at risk of bankruptcy within the next parliament, it is no longer possible to blame individual governance issues.

"There clearly is a systemic issue and rather than bunging local government panicked injections of cash, whoever wins the next election will need to reform the entire system, bringing back multi-year settlements based on an area's need and developing new ways of revenue raising."
